INSTRUCTIONS FOR SIGN PERMIT APPLICATION

All signs erected in the Village of Honeoye Falls require a Sign Permit and must be obtained prior to beginning any work. For complete sign requirements, please refer to Chapter 190 Article X of the Village Code. This can be viewed on line at: www.villageofhoneoyefalls.org, then click on Village Code, then click on Zoning, scroll down to Article X and look for 190-88 Signs.

Applicant must submit a site map showing sign location, all existing structures on the premises and dimensions between sign and all roadways.

Applicant must submit a description of the sign including: drawing to scale showing type of material; colors; dimensions of sign; wording on sign and show position of any lighting. If sign is wall mounted then provide the dimensions of the building façade upon which the sign is to be mounted. If an existing sign already exists and will remain then submit dimensions of existing sign. These documents must accompany the completed application, which will then be reviewed and approved by the Code Enforcement Officer. No sign shall be erected before approval and issuance of a Sign Permit.

If sign is a projecting sign and protrudes over a public right of way then submit a certificate of liability insurance coverage naming the Village of Honeoye Falls as an additional insured.

All electrical work must be inspected by an authorized agent and produce a certificate of approval. The following are Village approved electrical inspectors: Commonwealth Electrical Inspection Service 585-624-2380; New York Board of Underwriters 800-595-9600; Genesee Star Agency 585-768-6696; New York Atlantic-Inland 607-753-7118; Middle Department Inspection Agency 518-273-0861. It is the permit holder's responsibility to arrange for all required electrical inspections.

Upon the installation of the sign, the Code Enforcement Officer must perform a final inspection and issue a Certificate of Compliance. Applicant is responsible for requesting this inspection.
